

# **Event Scoring Policy**

Canadian Cheer is proud to host one-day, two-day & speciality events for the upcoming season. Please take the time to read through this document to ensure you are well-informed on how legalities will be assessed for each event type.

#### **One-Day Events**

- Fall-Classic
- Montréal Mayhem
- Cheer for the Cure (levels 1-4)

### **Two-Day Events**

- Cheer for the Cure (Worlds Teams)

## Safety/Legality Deductions

- Please ensure you have all official prop approvals sent to **justin@canadiancheer.com** prior to competing.
- Please ensure you have quick access to any skill approval videos from rules@cheercanada.ca and/or the IASF. These do NOT need to be sent in prior to competing. <u>The skill must be performed exactly as on the video in order for infraction to be overturned by scorecheck officials.</u>
- Reminder that worlds teams are assessed using the IASF deduction sheet which includes a MAX pyramid fall (-6pts)

### **One-day events:**

- A safety infraction is applied if the majority of the groups (more than 50%) perform a skill illegally
- If only one group performs a particular skill illegally, i.e. in level 2, a single toss group performs a pike toss in the opening, the team would receive a full safety deduction.
- If multiple athletes perform an out of level skill in the same section, one deduction may be assessed per rule violation, per section, not for each individual athlete/group. If the judge feels there is an imminent safety concern or blatant disregard for the rules, additional deductions may be assessed.
- Deductions can be assessed prior to, during or after a performance
  - Illegal skill or point deduction anytime during performance
  - If rules are not followed during the event, a deduction can be given outside of the team's performance (IE general safety, image policy, sportsmanship, etc)

### Two-day events:

Multi-performance events are events in which scores from each performance are a proportion of the total event score.

- All two-day events will be scored as follows: Day 1 = 30% Day 2 = 70%
- If an illegal skill is missed during performance one, and done again during performance two, the penalty will be assessed to the first performance score. Performance one score is equivalent to the lowest weighted/percentage score when possible.
- If a skill is warned during performance one and the skill is performed illegally in performance two (even by a different group or athlete in the same section) a deduction may be assessed.

### **Speciality Events:**

- These events will be scored separately from any other event that may be happening during the same weekend, this includes legalities.
- Speciality events will **NOT** be subject to the 50% rule stated under one-day events, even if they are single performance events.
- When the speciality event occurs after, before, or during a one or two-day event, performances during those events will not be considered when assessing legalities during speciality events.
- Legality officials will assess legalities as they see fit and may give an infraction for an illegal skill performed by a team regardless of how many stunt groups perform it illegally. (ie: only one group out of three performs a skill illegally, this could result in a full 4 pts deduction)
