



Event Scoring Policy

Canadian Cheer is proud to host one-day, two-day & speciality events for the upcoming season. Please take the time to read through this document to ensure you are well-informed on how legalities will be assessed for each event type.

One-Day Events

- Fall-Classic
- Cheer for the Cure (levels 1-4)
- Big East Blast
- Montréal Mayhem
- Battle at the Border
- Winterfest

Two-Day Events

- Cheer for the Cure (Worlds Teams)
- Canadian Cheer Fest
- Canadian All-Star Nationals
- Ontario Championships
- Québec Championships
- Canadian School Nationals

Speciality Events

- Border Showdown
- Canadian Face-Off
- Big East Showdown
- Canadian Finals

Safety, Out of Level, Violations & Legality Deductions

- Please ensure you have all official prop approvals sent to justin@canadiancheer.com prior to competing.
- Please ensure you have quick access to any skill approval videos from rules@cheercanada.ca and/or the IASF. These do NOT need to be sent in prior to competing. The skill must be performed exactly as on the video in order for infraction to be overturned by scorecheck officials.
- Reminder that all teams are assessed using the IASF deduction sheet

One-day events:

- **Out of Level Policy:** Even if only a single group performs an infraction in a section: 1 point deduction from that specific section will be assessed per infraction
- **Legalities Policy:** If a single group performs an infraction in a section, a warning will be given. If multiple groups perform the same infraction in a section a 4 point deduction will be given per infraction.
- Deductions can be assessed prior to, during or after a performance;
 - Illegal skill or point deduction anytime during performance
 - If rules are not followed during the event, a deduction can be given outside of the team's performance (IE general safety, image policy, sportsmanship, etc)

***Disclaimer:** If there is only one group or individual performing a specifically choreographed skill illegally, the full deduction will be applied*

Two-day events:

Multi-performance events are events in which scores from each performance are a proportion of the total event score.

- All two-day events will be scored as follows: Day 1 = 30% Day 2 = 70%
- **Out of Level Policy:** Even if only a single group performs an infraction in a section: 1 point deduction from that specific section will be assessed per infraction
- **Legalities Policy:**
 - **Day 1:** If a single group performs an infraction in a section, a **warning** will be given. If multiple groups perform the same infraction in a section a **4 point deduction** will be given per infraction
 - **Day 2:** If a single group repeats the same warned infraction: **4 points** deduction
 - If an infraction is not caught on Day 1 but is identified on Day 2 (provided it was performed in the same manner), a **4 point deduction** will be retroactively applied to the Day 1 score.

Disclaimer: If there is only one group or individual performing a specifically choreographed skill illegally, the full deduction will be applied

Speciality Events:

- These events will be scored separately from any other event that may be happening during the same weekend, this includes legalities.
- When the speciality event occurs after, before, or during a one or two-day event, performances during those events will not be considered when assessing legalities during speciality events.
- Legality officials will assess legalities as they see fit and may give an infraction for an illegal skill performed by a team regardless of how many stunt groups perform it illegally.
